

Frequently Asked Questions



Who can participate in F2F?

The F2F campaign is specifically for TSA chapters; students, teachers, parents, or any other individuals or groups are not able to participate.

What does it mean to be a chapter that is “eligible” for inclusion in the random selection process to receive \$1000?

“Eligible” chapters (for the random selection) include:

- existing affiliated chapters that have successfully recruited a new chapter;
- new chapters that were recruited through the F2F campaign;
- existing affiliated chapters that have maintained or increased their membership numbers from the 2023-2024 school year.

What recognition will be given to F2F chapters?

- All eligible chapters are entered into a random selection process to receive \$1000.
- Members and advisors of eligible chapters who attend the 2025 National TSA Conference will receive special Forward to Fifty name badge ribbons.
- Eligible chapters will be listed on the TSA website and in the 2025 National TSA Conference program.

When is the deadline for participation?

April 15, 2025

How will chapters be selected to receive \$1000?

All eligible chapters will be entered into a random electronic selection.

How many chapters will receive the \$1000?

Seventy (70) qualifying chapters will be selected to receive \$1000.

- When an existing chapter successfully recruits a prospective chapter and the prospective chapter affiliates with TSA, the existing recruiting chapter has the opportunity to receive \$1000. There are 50 opportunities for existing chapters to receive \$1000.
- There are five (5) opportunities for prospective middle schools and five (5) opportunities for prospective high schools that affiliate with TSA to receive \$1000.
- Five (5) existing middle school chapters and five (5) existing high school chapters with membership that has been maintained or increased (based on 2023-2024 membership) have the opportunity to receive \$1000.

How can my chapter participate if neither the members nor I am aware of a school without a TSA chapter?

What happens after I fill out the Recruitment Intention Form?

National TSA will review your submission and confirm approval for you to move forward with recruiting and mentoring the prospective identified school.

If I have been recruiting a chapter that affiliates this year, can I still fill out the Recruitment Intention Form?

Yes. Please fill out the form so that TSA will know that your chapter has engaged in recruiting a new chapter.

If my chapter membership has stayed the same or increased (based on 2023-2024 membership numbers), what do I have to do to participate?

Your chapter does not have to do anything to participate. TSA will determine eligible chapters based on a comparison of new membership numbers to 2023-2024 membership numbers. Eligible chapters have the opportunity to receive \$1000.

Five (5) existing middle school chapters and five (5) existing high school chapters with membership numbers that have stayed the same or increased will be randomly selected to receive \$1000.

Could my chapter receive more than \$1000?

The maximum amount any one chapter may receive is \$1000.

Who can fill out the Recruitment Intention Form?

Only the chapter advisor from an existing chapter may complete and submit the Recruitment Intention Form.

Are there any scholarship opportunities linked to Forward to Fifty?

No, Forward to Fifty is not a scholarship program.

My chapter didn't affiliate with TSA last year. Can my chapter participate in the F2F campaign this year?

A currently affiliated chapter that did not affiliate last year may only participate as an existing chapter that recruits a potential new chapter.
