

State Advisor of the Year Award



DESCRIPTION

The State Advisor of the Year Award is presented to a TSA state advisor who has provided exemplary service and support to TSA for the last three years only. Current members of the TSA, Inc. Board of Directors cannot be nominated during their respective terms of office. Both past and current contributions are considered. State advisors cannot receive this award two years in a row. Cover sheets and additional materials are not accepted. The recipient is recognized at the national TSA conference.

WHO QUALIFIES

TSA State Advisors who have shown outstanding performance in the following areas:

1. Member recruitment initiatives
2. Attendance at state and regional competitions/conferences
3. Participation in national TSA conferences
4. Training and support to TSA chapter advisors
5. Leadership in and commitment to TSA

WHO CAN NOMINATE

Three active TSA chapter advisors (from the same state) must collaborate on the nomination of the state advisor. The nominating chapter advisor should submit the form, indicating contact information for the two supporting chapter advisors. The two supporting chapter advisors must have knowledge of and approve of the nomination.
